

Test Administration Recommendations by Grade

MAP Growth comes in two versions: MAP Growth (designed for independent readers, appropriate for grades 2+) and MAP Growth K-2 (designed with extra audio support for non-independent readers).

Test Windows

MAP Growth and MAP Growth K-2 interim assessments can be administered three times per year: in the fall, winter, and spring. We recommend keeping all test windows short (3-4 weeks) and consistent from year to year, with 9-12 weeks between windows when possible. This timing ensures that students are compared to one another after receiving about the same amount of instruction; helps you accurately compare results to norms; and supplies valid growth comparisons from year to year.

Recommended Time Between Fall and Spring Testing	~32 weeks of instruction
